Article 3 Tariff of reimbursements

2. Reimbursements for (ISIC/ALIVE)	
a) License and issuance of an ISIC/ALIVE card	600 CZK
b) Renewal of the ISIC/ALIVE card license in due time	300 CZK
c) Extension of the ISIC/ALIVE card license after the due date	320 CZK
d) Issuance of a new ISIC/ALIVE card – damage, loss	600 CZK
e) Issuance of an identification student's card	300 CZK
f) Issuance of an identification student's card – damage, loss	300 CZK
3. Payment for the issuance of a copy/duplicate of the diploma	2 500 CZK
4. Other reimbursements	
a) Payment for an Individual Study Plan (ISP)	5 000 CZK
b) Payment for enrolment/activation in a higher year/semester outside the specified date in academic year schedule	1 000 CZK
